Privacy Policy for California Consumer Privacy Act

PT KLINE LOGISTICS INDONESIA (hereinafter referred to as "we," "our," or "us") respects your concerns about privacy. This Privacy Policy for the California Consumer Privacy Act (hereinafter, "CCPA Privacy Policy") applies solely to California consumers and addresses the Personal Information (as defined below) that we collect online and offline. - "Sell," "selling," "sale," or "sold," which means the selling, renting, releasing, disclosing, disseminating, making available, transferring, or otherwise communicating orally, in writing, or by electronic or other means, your Personal Information by us to another business or a third party for monetary or other valuable consideration.

2. Your Rights and Requests

If you are a California consumer, you have certain choices regarding your Personal Information, as described below:

- I. <u>Access:</u> You have the right to request, twice in a 12-month period, that we disclose to you the following information we have collected, used, disclosed, and sold about you during the 12 months preceding your request:
 - (I) The categories of Personal Information we collected about you;
 - (II) The categories of sources from which we collected such Personal Information;
 - (III) The business or commercial purpose(s) for collecting such Personal Information about you;
 - (IV) The categories of third parties with whom we shared such Personal Information;
 - (V) The specific pieces of Personal Information we have collected about you; and
- II. <u>Deletion:</u> You have the right to request that we delete certain Personal Information we collected from you.

Verifying Requests. To help protect your privacy and maintain security, we will take steps to verify your identity before granting you access to your Personal Information or complying with your request. If you designate an authorized agent to make an access or deletion request on your behalf, we may require you to (1) provide the authorized agent signed permission to do so, (2) verify your own identity directly with us (as described above), and (3) directly confirm with us that you provided the authorized agent permission to submit the request.

Additional Information. If you choose to exercise any of your rights under the CCPA, you have the right to not receive discriminatory treatment by us. To the extent permitted by applicable law, we may charge a reasonable fee to comply with your request.
